MPE PTA reserves the right to reject any banner it feels does not comply with the mission and goals of MPE PTA or with the standards of the Orange County Public School System. Political, alcohol, tobacco and other related types of advertising will not be accepted. Existing banners do not require approval, unless the banner will be replaced with a new banner design. Existing banner advertisers must provide this signed agreement and payment by the deadline date listed below or their banner will be removed.
